The Buyer wishes to purchase heating fuel (the "Product") from the Seller. The Buyer and Seller agree to the sale and purchase of fuel on the terms set out below.

1. The Buyer agrees to purchase fuel in such amounts as the Buyer may order to be delivered from the Seller to the Buyer's delivery address.
2. The Buyer owns the fuel immediately upon delivery of fuel into the Buyer's storage facility/tank and agrees to pay for any such fuel at the price set from time to time by the Seller.
3. The Buyer will pay for all delivered Product within the Credit Limit and Credit Term provided below. Failing such payment, the Buyer agrees to pay 1% per month interest on all overdue amounts, calculated daily from date of invoice to date of payment. The Buyer will be responsible for all costs, including legal fees on a solicitor-client basis, incurred in collecting any overdue payment.
4. The Buyer agrees that the metered amounts shown in the records of the Seller are correct, except if there are errors or omissions.
5. The Seller will render invoices at regular intervals, to be determined by the Seller.
6. The Seller has the right to deny sales to the Buyer at the discretion of the Seller upon seven (7) days' notice by any means to the Buyer, or at any time that the Buyer is in default of the terms of this Agreement.
7. The Seller will exercise all due caution when delivering fuel to the Buyer. Agents/Employees of the Seller will take care to ensure that no fuel product is spilled at any time when delivering fuel to the Buyer's storage/tank facility.
8. The Seller will ensure that any spill is reported immediately to the Buyer.
9. The Seller cannot guarantee supply, and in the event of shortages beyond the control of the Seller, the Seller will provide the Buyer with as much notice as possible of such shortage.
